**WHAT:** 9K (~6mile) or 5K trail run around the perimeter of The Land Conservancy's (TLC) Stateline Woods and Auburn Heights II Preserves.

**WHEN:** *Saturday, May 12, 2012* Registration begins at 7:30 a.m. Race Starts 9:00 a.m.

**WHERE:** Start/finish is at 814 Merrybell Lane entrance to Stateline Woods Preserve off Old Kennett Pike in Kennett Square, PA, near Hockessin, and Centreville, DE.
