**Directions to race start:**

**From the South:** Heading north into Lancaster, Rt. 272/222 becomes Queen St. Turn right at the first traffic light (Chesapeake St.) at the bottom of the hill, turn right into the park.

**From the North:** Rt. 501, 222, 272 south on Lititz Pike. Over the railroad bridge, road bends right. Turn left on Duke St. (first left) and follow signs south through town. Continue south to traffic light at Chesapeake St. Turn right on Chesapeake St. at bottom of the hill turn left into the park.

**From East and West:** Head into Lancaster, turn south on Duke St. Continue south to traffic light at Chesapeake St. Turn right on Chesapeake St. at the bottom of the hill, turn left into the park
