I acknowledge that I have been advised by the YMCA of Reading and Berks County to consult a physician prior to participation. I acknowledge that if I believe the event conditions are unsafe for me or my minor children, I will immediately discontinue participation in the event. I fully understand the event involves risk of serious bodily injury, including permanent, disability and death, which may be caused by: my own actions or inactions, the actions or inactions of others; the conditions in which the event takes place, and/or the negligence of the Releasees named below.

I also understand that there may be other risks not known to me or not readily foreseeable at this time. I give my permission for photographs taken at the event in which my image or the image of any of my minor children appears, to be used for promotional and/or advertising purposes by the YMCA of Reading and Berks County, without compensation to me or my minor children. I agree to release the YMCA of Reading and Berks County from all claims and liability related to the use of my name, likeness, photograph or statement.

I fully accept and assume all risk and responsibilities for losses, costs and damages that I incur in connection with my participation or the participation of my minor children, in the event. I hereby release for all liability, discharge and covenant not to sue: The YMCA of Reading and Berks County, it administrators, directors, agents, volunteers, and employees, other participants, sponsors, advertisers, and the owners and lessors of the premises on which the event takes place (all and each of the foregoing are õReleaseesö).
