**LOCATION:** Race will be held at **Union Jack's Inn on the Manatawny, 546 Manatawny Road; Boyertown, PA**

**COURSE:** Join us for a wheel-measured 3.1 mile run on country roads and along a stream through the scenic Oley Valley. Course runs through a Historic Covered Bridge and ends with a challenging finish.

From **Boyertown:** Route 73 West to left on Tollhouse Road to left on Manatawny Road to Union Jack's.
