COURSE: FLAT, FAST course on mostly shaded trail. Great opportunity to get a personal record! Starts and ends at Scott Park.

AWARDS 5k Run - Prizes will be awarded to the top male and female finishers. Top three (3) finishers in each of the following age groups will receive an award, both male and female: 15 & under: 16-19: 20-29: 30-39: 40-49: 50-59: 60+.

5K Walk – Prize will be awarded for the Top Finisher (1)

ENTRY: **5K Run or Walk** \$25 (\$30 day of) – Includes food/drinks after event. Includes shirt if registered by Friday Sept 7th. Day of registration starts at 7:30am. Race starts after Kids Fun Run.

- **Kids Fun Run** \$10 – Includes food/drinks after event and Kid Grab Bag. Must be 12 & under to participate. Starts at 9:00am. Shirt not included.

- Rain or Shine Event timed by Pretzel City Sports (In the event of cancellation due to lightning your registration will be considered a donation)

DIRECTIONS Heading West on 22 from New Jersey: Take 3rd Street Exit in Easton. Turn Left onto 3rd Street. Turn Left onto Bushkill St. Go around the bend (Bushkill turns into Larry Holmes Dr). Scott Park will be on the left.

DIRECTIONS Heading East on 22 from Easton: Take 4th Street Exit in Easton. Turn Left onto Bushkill St. Go around the bend (Bushkill turns into Larry Holmes Dr). Scott Park will be on the left.
