July 12, 2007 – June 25, 2017

Evan was the kind of boy who would walk into a room and immediately make friends. His smile was infectious and his heart immensely kind.

Tragically Evan lost his life in an accidental fire in his father's home on June 25, 2017. Our whole lives changed on that day. Suddenly the laughter and jokes were missing and the smile that lit up the room disappeared from our lives.

We want others to know Evan's kindness and help it to live on. Evan learned many lessons in his short but remarkable life. These lessons are now affectionately known as **Evan's Eleven**.

We are continuing our partnership with the surrounding fire communities to create additional fire safety prevention and awareness through the **Saving Lives Campaign and Evan's Eleven Inc.** Proceeds from Evan's Eleven Memorial 5K & Day of Kindness Event will be donated to honor those causes.
