**LOCATION:** Riverfront Park, 140 College Dr., Pottstown, PA 19464 Registration opens at 5:30 PM

**COURSE:** Trail run, pavement flat and primarily straight but has some turns. Walker & Stroller Friendly. You will run up to the halfway point where there will be people directing you to turn around and run back over the bridge. Once crossing the bridge there will be someone directing you to go on the gravel path where you will end at the pavilion.

**AWARDS:** Top M and F overall and top 3 M & F in each of the following age groups:  
0-14      15-19      20-29      30-39      40-49      50-59      60+

**ENTRY:** If postmarked by June 9, 2018; \$20 for ages 18 & above, \$15 for ages 10 through 17, \$5 for kids 9 and below. Includes a guaranteed shirt in the size you order, except for those 9 and under (due to the reduced price and no kids sizes offered). After June 9<sup>th</sup>, including race day, \$25 for ages 18 & above, \$20 for ages 10 through 17, \$10 for kids 9 and below. Again, other than those 9 and below, includes a shirt while supplies last.
