COURSE: The Trail has a few muddy areas, a few Creek crossings, fallen trees, roots and vines, a few short hills, some open fields and lots of fun. You can choose the 5K (3.11 miles) **OR** the 10K (6.22 miles) option. **This is not your average 5K/10K!**

We will have chip timing again this year, (2) instant results kiosks at the finish line and a 40" HDTV with scrolling results!

AWARDS for 5K/10K: Separate awards for the male and female overall winners plus 1st, 2nd and 3rd in each age group both male and female 12-15, 16-18, 19-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60+ . **10K** 12-15, 16-18, 19-29, 30-39, 40-49, 50-59, 60+. Awards are based on pre-registered runners. Age groups with no pre-registrations at the cutoff date will not have an award.

ENTRY: 5K or 10K: \$30 if postmarked by Friday, March 29th, 2019. Afterwards, plus race day, \$35 (shirts while they last)
