**WHAT:** The Run for Liberty 5K is a fundraiser for the Liberty Fire Company #4 with all proceeds benefitting the new truck fund! Our mission is to aggressively save lives and property, not only in our community but the surrounding communities that rely on our services.

**LOCATION:** The Liberty Fire Company #4 Parking Lot, 223 West Columbia Street, Schuylkill Haven, PA. Registration opens at 8:00 a.m. 5K Run/Walk starts at 9:00 a.m. Short sleeve t-shirt to all pre-entries. Race day registrants not guaranteed a shirt. Race is timed and scored by Pretzel City Sports, clock at finish, refreshments, and instant results. Event is rain or shine. No refunds or mailed awards. Other events include a Kauffman's Chicken BBQ, 50/50 drawing, music and additional food and beverages available for purchase.

**COURSE:** FLAT, FAST combined road/trail. Route travels through the town of Schuylkill Haven and onto "The Island" run/walk trail. This makes for a GREAT course to PR!

**AWARDS 5K:** Runners will be awarded according to age categories: 1<sup>st</sup> and 2<sup>nd</sup> place - Male and Female - Ages: 14 and under; 15-19; 20-29; 30-39; 40-49; 50-59; 60-69, 70+; Overall winner: Male and Female

**\*SPECIAL AWARDS:** Top 3 Overall Emergency Responders

**ENTRY:** 5K Run/Walk: \$25 if postmarked by JULY 31, 2019, t-shirt guaranteed. Afterwards, plus race day, \$30, t-shirts available while supplies last.
