

## Nighttime Trail Race 5k, 10k or 15k Friday, August 23, 2019 7:30 P.M. Blue Mountain Resort, Palmerton, PA

**LOCATION/REGISTRATION:** Blue Mountain Resort, 1660 Blue Mountain Drive Palmerton, PA 18071. Race starts and ends in the Valley. Parking in the Valley lot. Registration/number pickup in Valley Adventure Center from 6:00 P.m.-7:00p.m. Trail race starts at 7:30p.m.

**DETAILS/COURSE:** 5k, 10k or 15k-choose your distance. All races are held on a 5k loop on the grounds of Blue Mountain Resort. The 5k runners will complete one loop, the 10k runners will complete 2 loops and the 15k runners will complete 3 loops. Register for one distance with the option to change during the race. All races are the same price and all begin at 7:30pm. The course will be a combination of fields, woods, service roads and ski trails.

Course will be marked with reflective signs. Runners are required to wear a headlamp. Clock at finish, refreshments, instant results. Rain or shine. No refunds or mailed awards.

**AMENITIES:** Performance t-shirt and LED glow bracelet guaranteed to all pre-registrants. Free entrance into BeerFest-live music & beer samplings (for runners 21 or over-value of \$45) immediately following race conveniently located in the festival area just beyond race's finish. Event ends promptly at 10pm so run fast! All runners under 21 will receive a voucher for a pass to the Summit Aerial park. Refreshments for finishers, time clock at finish and instant results. After August 9<sup>th</sup> including race day, shirts only available while supplies last.
