**Details/Course:** 5K out and back to the Summit lodge. Course will be different each event, but will include some dirt trails, ski trails and hills. No frills race, light refreshments, instant results, 1 FREE BEER WITH EVERY ENTRY! (must have proof of valid ID) Held rain or shine! ENTRY DOES NOT INCLUDE A SHIRT BUT SHIRTS WILL BE AVAILABLE FOR SALE THAT NIGHT. No refunds or mailed awards.

**SERIES Awards:** Overall Series Winner: Overall Top M & F, Overall Age Group Winners M & F in 14 & under, 15-19, 20-29, 30-39, 40-49, 50-59, 60+ (Must race in 4 out of 5 events to qualify) The team that has the most participants throughout the series will also get an award!

**Individual Race Awards:** 1<sup>st</sup> overall male and female and recognition to all age group winners

**Solo or Team Member SERIES Entry:** Series \$75 for the 5 races if postmarked by May 13<sup>th</sup>: \$85 after that for series including night of first race.
