Location/Registration: Race starts and finishes at 180 Forest Rd. Denver, PA 17517. Parking is in grassy areas. Registration/Bib pickup opens at 8am with the 4 mile race beginning at 9am. Cash or Check only for race day registrations. Walkers are welcome.

Course: The course is GPS measured 4 miles and will take you through well groomed dog training trails as well as up long climbs with some fast descents to follow

Amenities: Pre-registered participants will receive a unisex soft cotton shirt, 1 water station on course, bathroom facilities, a hose to wash off with, and post race BBQ chicken (to purchase)

Awards: Awards will be given to the top male & female overall. Plus age groups will go three deep M/F as follows; 19&Under, 20-29, 30-39, 40-49, 50-59, 60+

Kids Fun Run: Post race 1/2 mile kids fun run for ages 12 & under. 5\$ up until and including race day, shirts not included. Finisher ribbons & goodie bags (while supplies last) to all fun run finishers. (Race Start approx. 10am)

4 Mile Entry: 30\$ with shirt if postmarked by May 21st. 25\$ without shirt, up to and including race day. Optional online registration @ www.pretzelcitysports.com (small service fee applies, online registration closes at midnight the Wednesday before race day)
