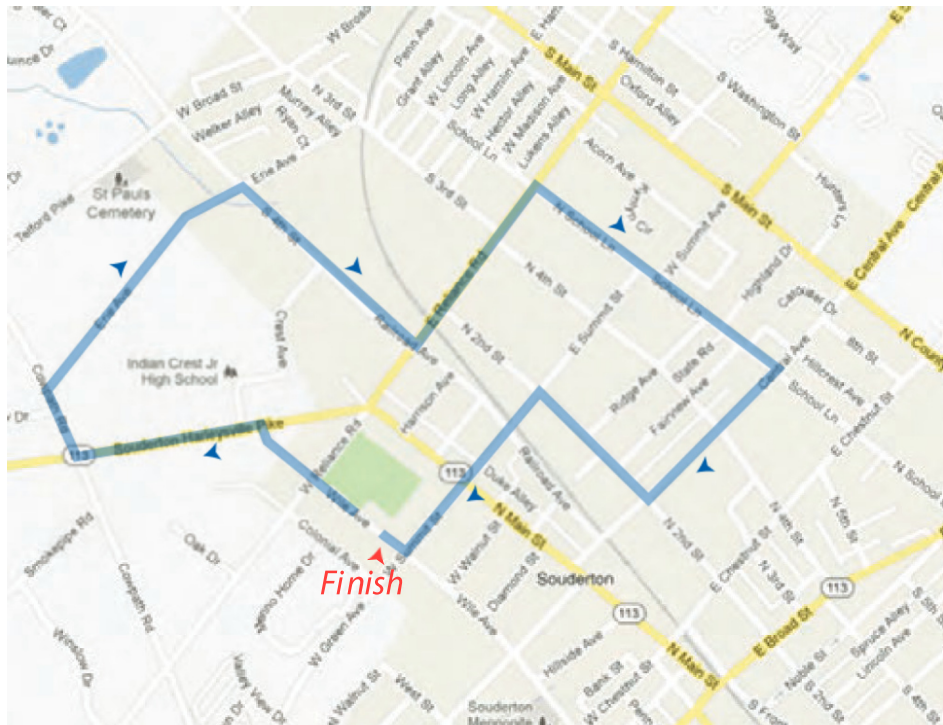

I verify that I am physically fit and have trained sufficiently for the race.

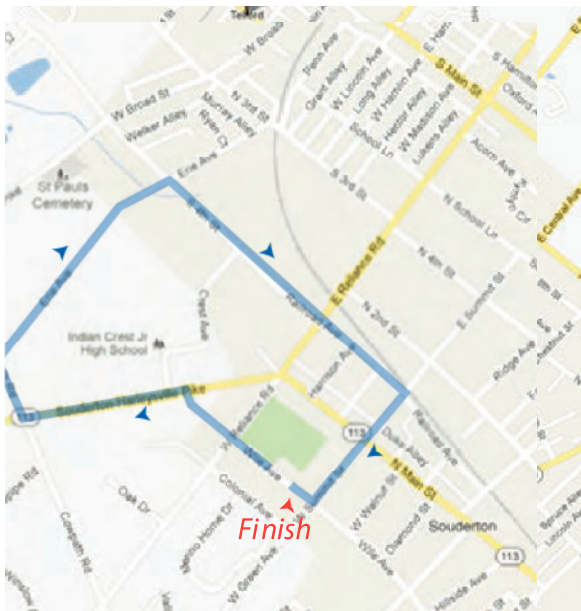
