10K Run & 5K Walk

Presented by the Northern Lancaster County Game & Fish Association

Saturday February 18, 2023 @ 9:30am

Location/Registration: Race starts and finishes at 180 Forest Rd. Denver, PA 17517. Parking is in grassy areas. Registration/Bib pickup opens at 8:00am with the race beginning promptly at 9:30am. Cash or Check only for race day registrations. Race will take place rain, shine, or snow - as long as roads are driveable.

Course: GPS measured 5K loop will take you through well groomed grass dog training trails as well as up long climbs with some fast decents to follow. The 10K timed race will run the loop two times. The untimed, non-competitive, 5K will complete the loop once.

Amenities: Pre-registered participants will receive a unisex long sleeve shirt, 2 water stations on course that you can utilize multiple times, bathroom facilities, and wash hose.

10K Awards: Cash awards and medals will be given to the top male & female overall. Age group medals will go three deep M/F as follows; 19&Under, 20-29, 30-39, 40-49, 50-59, 60-69, 70+

10K Run Entry: 40\$ with shirt if postmarked by Feb. 1st. 30\$ after that date, up to and including race day; no shirt.

5K Walk Entry: 25\$ with shirt if postmarked by Feb. 1st. 15\$ after that date up to and including race day; no shirt.

Kids Fun Run: Post race ½ mile kids fun run for ages 12 & under. 5\$ up until and including race day, shirts not included. Finisher medals & goodie bags (while supplies last) to all fun run finishers. (Race Start approx. 11am)
