**COURSE:** The race will start and end at the **Mohnton Playground- Walnut St, Mohnton, PA 19540 off E. Wyomissing Ave.** Google Maps: 202 E. Wyomissing Ave. will take you to the parking lot. The course will be in and around the park. **This is a measured course!**

**TIME:** April 23, 2023. Registration starts at **7:45 AM**, the race will begin promptly at **9:00 AM**. Timing services provided by Pretzel City Sports.

**AWARDS:** Separate awards for Top Male and Female Overall plus top 3 male and female for the following age groups: 18-29, 30-39, 40-49, 50-59, 60-67, 68-74, 75+. Award ceremony will begin at **10:00 AM**.

**AFTER RACE:** At the end of the race, we will be providing light snacks and soft drinks to all. There will be a vendor fair to connect runners and the community to services available in your area, live demonstrations, and more!
