# 2023 Liability Waiver

**WAIVER:** I know that running a trail race is a potentially hazardous activity. I should not enter and run unless I am medically able and properly trained. I acknowledge that if I am sick, I should not attend the Event. I also know that there could be hazards on the course and assume the risk for running on the trail. I also assume any or all other risks associated with running or attending the race including but not limited to falls, contact with other participants, the effects of the weather and the condition of the trails, all such risks being known and appreciated by me. Knowing these facts, and in consideration of your accepting my entry fee, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant not to sue, and waive, release and discharge the Reading-Berks Association of REALTORS, Pretzel City Sports, the County of Berks, including their Parks & Recreation Department and any subcontractors it utilizes, all municipalities in which the race is held, the race committee, volunteers, any and all sponsors including their agents, employees, assigns or anyone acting for or on their behalf, or anyone else associated in any way with the race, from any or all claims or liability for death, personal injury or property damage of any kind of nature whatsoever arising out of, or in the course of, my participation in this event(s). This waiver extends to all claims of every kind or nature whatsoever, foreseen or unforeseen, known or unknown.

In the event of an illness, injury or medical emergency arising during the event, I hereby authorize and give my consent to any R-BAR Staff member or volunteer to secure from any accredited hospital, clinic and/or physician any treatment deemed necessary for my immediate care. I agree that I will be fully responsible for payment of any and all medical services and treatment rendered to me including but not limited to medical transport, medications, treatment, and hospitalization.

Registration and attendance at the 5K Run for Shelter (hereinafter referred to as "Event") and other activities constitutes an acknowledgment of the risk of COVID-19.
