**COURSE:** Come run this beautiful gently rolling Amish farm country course. Take in the views of beautiful pastoral scenery as you race towards your PR! Roads will be closed so you can focus on your running.

**AMENITIES:** T-shirt and swag bag guaranteed if registered for the 5K/Fun Run by April 1st. After that date including race day, swag bag & T-shirts (as supplies last). Refreshments are available, indoor toilet facilities, school parking, a time clock at the finish, and instant results. Held rain or shine. No refunds or mailed awards.
