LOCATION/REGISTRATION: Starts at Can Corporation of America – 326 June Ave, Blandon, PA 19510; Registration/number pickup starts @ 8:00 AM. 5K at 9:00 AM, FUN RUN at the conclusion of the race or 9:45 AM – age doesn't matter 😊

COURSE: Will start @ Can Corporation of America (CCA), wind around our Giorgio "Farm of the Future," head back down June Ave, take a tour of the surrounding neighborhood and finish back at CCA's facility.

AMENITIES: T-shirt to all preregistrants of 5K; "goodie" bag for all kids 12 & under who participate in the FUN RUN. Refreshments for finishers, outdoor toilet facilities, loads of parking, time clock at finish and instant results. Held rain or shine. No refunds or mailed awards. AWARDS: Trophies for the Overall Winner - 1 Male & 1 Female; Medals for 1st, 2nd & 3rd place Male & Female winners in each age category. Collectible completion medallions will be handed out to all. ENTRY – 5K & Fun Run: \$30 if completed by October 6th, 2025 (T-shirt included). Afterwards, including day of race, \$35 while shirts last, \$30 once shirts run out. FUN RUN age 12 & Under - \$10 (NO T-shirt included). Race day Fun Run registration for 12 & under to be CLOSED once we have as many entries as we have goodie bags so preregister if possible.

GENERAL DIRECTIONS FOR ALL to CCA – 326 June Ave, Blandon PA 19510: From Reading (South) - Take Rt. 422 W to US-222N to Park Rd in Ontelaunee Township. Take the US-222 BUS S exit from US-222 N. Continue onto Park Rd, turn left at Excelsior Drive, then left on June Ave and follow signs. From Hamburg (North) – Take PA-61 S to PA-73 E & turn left. Continue to Park Rd and turn right. Follow to Excelsior Dr, make right, turn left on June Ave and follow the signs.
