REGISTRATION: Registration is \$35.00 for all race/walk options with tshirt guaranteed if registered by March 29th. After that date and including race day \$40.00 and shirts are available while supplies last.

Online registration is available at pretzelcitysports.com (a nominal fee applies) and will close at midnight on Wed. April 22, 2026.. Walk-ups registrations will be accepted on the day of the race. Early T-Shirt/Package pick-up will be held at Jim Dietrich Park on **FRIDAY, April 24th** from 4:00PM to 6:00PM at the pavilion near the barn.

Awards: Top M & F plus top 3 M & F in the following Age Groups 15 & under, 16-19, 20-29, 30-39, 40-49, 50-59, 60-69 and 70 plus. **No awards for Virtual participants and 1 Mile Run/Walk**

RACE DETAILS: In-person event will take place through beautiful Jim Dietrich Park. The wheel-measured course is fast, relatively flat and timed by Pretzel City Sports. GREAT place to PR! Package pick-up and walk-up registration begins at 8:30 AM. The race will start at **10:00 AM**, walk starts at **10:30**. Virtual participation is to be completed April 25, 2026 at the location of your choice.
