Flat, Fast and Picturesque run along the Schuylkill River

Location: The Trout Run Sports Complex, 950 West Neversink Road, Reading, PA. Registration/Number pick-up opens at 7:30 A.M. 5k starts at 9:00 A.M.; 10k starts at 9:15 A.M.; 1 mile Fun Run/Walk at 9:45 A.M.

Course: FLAT, FAST wheel measured course on mostly shaded trail along the river. GREAT place to PR! Clock at finish, refreshments, instant results. Walkers are permitted. Rain or shine. No refunds or mailed awards.

Awards: Top M & F plus top 2 M & F in the following Age Groups 15 & under, 16-19, 20-29, 30-39, 40-49, 50-59, 60-69 and 70 plus for both the 5K and 10K. No awards for 1 Mile Run/Walk

Entry Fee for 5K/10k: with shirt: \$30 if postmarked by Friday, March 13. Afterwards, including race day, \$38 while shirts last, \$33 when gone. Without shirt: \$25 if postmarked by Friday, March 13. Afterwards, including race day, \$33. 1 Mile Fun Run/Walk is open to all ages and is FREE but requires completed registration form. Also, shirts are not included, due to no fee.

DIRECTIONS FROM EAST OF READING: Take 422 West toward Reading to Bus. 422 (Mt Penn) bears off to right. Stay right until Sheetz appears on left. Take left at that light onto East Neversink Road. Continue straight past Godiva Chocolate; continue until you go under overpass at intersection with Painted Sky Road. Enter parking lot to left.

DIRECTIONS FROM ALL OTHERS: Take 422 Reading Bypass until Mount Penn exit. Go right at blinker at top of exit. Continue straight past Godiva Chocolate; continue until you go under overpass at intersection with Painted Sky Road. Enter parking lot to left.
