First Responder Category: Overall M/F (1st, 2nd, 3rd); plus the following Age-Groups M/F 18-39 (1st, 2nd); 40+ (1st, 2nd).

Overall 1st, 2nd, 3rd Winners (both Open and First Responder) not eligible for Age-Group awards.

Entry for 5K Run/Walk: \$25 if postmarked by September 18th, includes guaranteed t-shirt. After September 18th (including race day), \$30 and t-shirt while they last.
